Upon receipt of payment, the nominated member for Organisation Memberships and Library Memberships will be mailed a membership kit containing a membership card, a copy of the agreed terms and conditions, and a tax receipt. Nominated members for Library memberships will also receive an EVA CD-ROM.

ORGANISATION MEMBERSHIPS AND LIBRARY MEMBERSHIPS – A SPECIAL NOTE ABOUT YOUR NOMINATED MEMBER

Within each organisation the nominated member acts as the coordinator of the service, and EPA Victoria Library staff will deal solely with this person for the duration of the membership. The nominated member acts on behalf of the entire organisation and is responsible for:

- Coordinating staff requests
- Renewing loans on time and ensuring they are returned in suitable packaging
- Booking appointments for staff to visit the library and providing staff with the membership card to enable loans and complimentary copying
- Ensuring all terms and conditions of the Corporate Client Subscription Service are observed
