1 Stakeholder Engagement

1.1 Purpose

Stakeholder engagement is regarded as an ongoing process and applies broadly to EAPL's operations. This plan has been developed specifically for the purposes of the Hastings Generation Project.

1.2 Stakeholders

Stakeholders are defined in this document as people, groups or communities that may be directly or indirectly affected by, or have an interest in, EAPL's operations. This is a diverse group that, over time will comprise locally affected communities or individuals and their formal and informal representatives, national, state or local government authorities, political leaders, civil society organisations, groups with special interests, the academic community, and other businesses.

Priority will be given to stakeholders who are directly affected by EAPL's activities, but stakeholder engagement will not exclude those that fall within a broader sphere of influence or whose legitimate interests define them as stakeholders.

Stakeholders identified relevant to this project are listed in Table 1-1.

1.3 General Enagagement Objectives

The overall objectives of the Company's stakeholder engagement activities are:

- To keep stakeholders informed with respect to their specific interests
- To ensure stakeholders (especially the directly affected) will be consulted on matters that affect them
- To maintain stakeholder confidence and trust in the Company and its activities through open, informative, inclusive and timely communications

These objectives will be achieved by adhering to the following principles:

- Provide meaningful information in a format and language that is readily understandable and tailored to the needs of the target stakeholder group(s)
- Provide information in advance of consultation activities and decision-making
- Disseminate information in ways and locations that make it easy for all stakeholders to access
- Respect local ways of doing things
- Establish two-way dialogue that gives both sides the opportunity to exchange views and information, to listen, and to have their issues heard and addressed
- Seek inclusiveness in representation of views, including minority and special interest groups
- Develop clear mechanisms for receiving, documenting, and responding to people's concerns, suggestions, and grievances
- Incorporate feedback into the program design, and report back to stakeholders in a reasonable time.

1.4 Project Specific Objectives

The objective of the Stakeholder Engagement Plan for the Project is to support the timely approval of all regulatory requirements and to provide stakeholders and the broader public with balanced and objective information to assist them in understanding the project and any problems, alternatives and/or solutions.

1.5 Strategy

To achieve the objectives, the following strategies will be implemented:



- Hastings Generation Project Stakeholder Engagement Plan
- Early engagement with Regulators and community to ensure clear understanding of the project
- Leverage existing community engagement activities and relationships to ensure adequate community consultation
- Maintain a record of engagements and issues arising to ensure consistency of approach and timely response to issues.

A summary of consultation is outlined in Appendix 1.

1.6 Key Messages

Key messages will underpin all Project communications material and will be evaluated on an ongoing basis as a result of new project information and feedback gained through consultation activities.

Key messages:

- Gippsland gas currently supplies around 40 per cent of eastern Australia's domestic gas needs through Esso Australia's production of oil and gas from Bass Strait
- The Long Island Point Plant has an important role in this supply of energy, processing the associated gas liquids from our Longford gas production, to create ethane, propane and butane.
- Propane and butane is sent to domestic and overseas customers via truck, ship or pipeline, while all ethane from Long Island Point is currently provided as feedstock to a petrochemical manufacturing facility in Melbourne's west.
- When our customer is unable to accept the ethane as a result of planned or unplanned maintenance, we either need to limit our supply of natural gas to reduce the transfer of gas liquids to Long Island Point, or flare the ethane.
- To improve community and environmental outcomes, we have identified an alternative for managing excess ethane that will reduce the need to flare at Long Island Point.
- Esso Australia is planning a project to install three modern, efficient ethane power generation units next to our Long Island Point plant. These will be capable of converting excess ethane, that would otherwise be flared, into 40 megawatts of clean electricity to power Victorian homes, while ensuring we can maintain our reliable supply of natural gas across the east coast.
- We expect there will be minimal impacts to the community from the construction of this project, which is set to take place within the existing industrial complex at Long Island Point during 2022.
- The Ethane Disposition Project (HGP) consists of using ethane from the LIP Facility to generate power by installing generators at the Esso owned site adjoining LIP. The electricity would be linked to the existing electricity transmission network via the Tyabb Terminal Station. There are three components to the project which can be summarised as:
 - Installing a new above-ground pipeline to transfer ethane from LIP to the adjoing Esso own HGP site.
 - Installing electricity generators (approximately 40MW) on the project site and connecting it to the new ethane pipeline.
 - Installing a high voltage electricity line from the generator and linking to the existing transmission network powerline on Bayview Road.
- Currently, ethane produced from LIP raw Natural Gas Liquids (NGLs) is transferred to Qenos Altona by pipeline. If this disposition method becomes unavailable, ethane can be disposed of (depending on the gas order) by a range of operational activities including Flare, NGL disposal and Gas curtailment.
- The supply of natural gas from the Longford Plant to the state of Victoria is considered to be an essential service under the Essential Services Act 1958. For this essential service to continue, there needs to be a continued means of disposing the products that are produced with the natural gas, in this case ethane, propane and butane. If the normal offtake of ethane ceased or was significantly reduced, the ability to continue to produce and deliver natural gas to Victoria at the

normal rate would be interrupted, unless an alternative use or means of disposal of ethane was available.

• The only immediate alternative for disposing of the ethane would be to put it to flare at LIP. As this is not permitted under the existing LIP Bubble Licence, it would require the Minister (under the emergency provisions) to provide an exemption for flaring until such a time as alternatives were made.
