# About this policy

Improved access to information and data sets held by government promotes transparency, stimulates innovation, commercial activity and community engagement, gives researchers access to primary data and improves the overall efficiency of government by encouraging re-use.

Environment Protection Authority Victoria's (EPA) 5 Year Plan focuses on being accountable and transparent, sharing EPA plans, results, data, information and learnings. This is supported by the Victorian **Government's Public Sector Information Release** Framework which focuses on the management and release of public information to Victorians.

This policy articulates EPA's position on information release, associated restrictions and supporting infrastructure.

### Policy statement

EPA will release its information to the public according to the Freedom of Information Act 1982 or as per the EPA information release schedule.

EPA will release its information unless one or more of the following restrictions applies:

- 1. EPA does not own copyright in and does not have permission from the copyright owner to release the information (Copyright Act 1968).
- 2. The information's security classification prevents release.
- Information release is in breach of government 3. policies, statutory or legislative requirements, for example.
  - 3.1. The information is commercially sensitive (Section 60, Environment Protection Act 1970,).
  - 3.2. The information contains personal information that has not been de-identified (Information Privacy Act 2000).
- The information is subject to a contract/agreement 4. that does not allow release.
- The information content is subject to law 5 enforcement activities, court orders, legal proceedings or legal privilege, including legal advice.
- It is in the public interest for EPA to retain 6. intellectual property (Section 13(1A), Environment Protection Act 1970).

# Definitions

The table below defines key terms used in this document.

Term	Definition	
Data	Raw facts without context	
De-identified	The removal of identifying information, with the aim of protecting the identify or confidentiality of an individual or organisation	
Freedom of Information	The Freedom of Information Act 1982 provides a legislative framework for access to documents held by Victorian public sector organisations. It is underpinned by the principles of open and accountable government and that people have the right to access information that is held about them	
Information	Data that has been explained, processed or organised into meaning within a context	
Public Sector Information	Information and data generated, created, collected, processed, preserved, maintained, disseminated, or funded by the Victorian public sector	

#### Security classification

Prior to release EPA will assess its information for the risk associated with inappropriate disclosure (in line with the Victorian Government's Information Security Policy, Copyright Act 1968, Environment Protection Act 1970 and Information Privacy Act 2000).

Assessment determines the level of security classification based on the sensitivity and protection level required. Sensitivity classifications include:

- For Official Use Only
- Sensitive
- Sensitive: Personal
- Sensitive: Legal
- Sensitive: Cabinet.



## Freedom of information

All information released under a Freedom of Information request (as per the *Freedom of Information Act 1982*) is assessed annually for suitability for general release to the public.

## EPA Information release schedule

All information is released according to the *EPA information release schedule*.

The EPA information release schedule identifies when specific information items will be released.

#### Release

All information items released are listed in the EPA Publications Database and all datasets released are listed in the EPA Data Directory.
